



Online Form Instructions

- For the purpose of ECI REC online forms, when the word “signature” appears, a typed, legal name is an acceptable substitute. As long as the complete, legal name appears in each blank for which a signature was requested, the form is accurate and binding (pending accurate completion of all other form sections). It is not necessary to print and sign the form if users plan on taking advantage of the “submit by email” option provided on the final page of each form.
- Some rebates may require the actual signature of mechanical engineers. ECI REC will follow-up with members applying for those rebates as necessary.
- Please do not fill out the “office only” sections of the form. Tab past them when filling out the form.
- Completed forms and required sales receipts or invoices may also be submitted to ECI REC via fax at (319) 443-4359. Please submit both the completed form and accompanying invoice(s) using the same method—fax or email—to ensure they arrive together at ECI REC.

Agreement – Grain Bins

THIS AGREEMENT, made and entered into this ____ day of _____, 2____ by and between East-Central Iowa REC, an Iowa Corporation with its principal place of business in Urbana, Iowa (hereinafter “Cooperative”), and _____, an individual residing in _____ County, Iowa (hereinafter “Member”);

WITNESSETH:

WHEREAS, Cooperative provides electric utility service at retail in its assigned area of service, and Member is a member consumer of Cooperative and purchases and receives electric utility service from Cooperative; and,

WHEREAS, the National Electric Safety Code established minimum clearance requirements for grain bins located in the vicinity of electric distribution lines; and,

WHEREAS, Member owns certain property located in _____ County, Iowa.

WHEREAS, Cooperative owns, operates, and maintains an electric distribution line adjacent to the property of Member, and Member has constructed and installed a grain bin on his property at distance of approximately ____ feet ____ of Cooperative’s distribution line; and,

WHEREAS, Member has established loading and nonloading sides for the grain bin as those terms are used in the National Electric Safety Code and Iowa Electric Safety Code; and,

WHEREAS, the parties desire to set forth in this Agreement the terms and conditions pursuant to which Member’s grain bin will be used at said location;

IT IS, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS HEREINAFTER SET FORTH, AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. Member acknowledges that Cooperative owns, operates and maintains an overhead electric distribution line approximately _____ feet, _____ of the location where Member has installed or intends to install a grain bin on Member's property.
2. Member hereby agrees that the _____ side of said grain bin is established and declared as the nonloading side of said grain bin for loading and unloading operations.
3. Member hereby acknowledges that the Cooperative had informed Member of the grain bin clearance requirements of the National and Iowa Electric Safety Codes.
4. Cooperative agrees to operate and maintain its electric distribution line in accordance with National and Iowa Electric Safety Codes, and Member agrees to operate, load, and unload the grain bin only from the _____ side, and to observe all safety requirements associated with the operation and use of said grain bin.
5. Member agrees to indemnify and hold Cooperative harmless from any and all injuries or death to persons or animals, and for damage to property, caused by or resulting from the construction, installation, operation, and use of the Member's grain bin at the location described in this Agreement.
